Note : The product causes corrosion on skin and mucous membranes. Note that in case of discharge of acidic or alkaline products into the sewerage system the pH must be in the range of 6-10 since higher or lower pH values may damage the sewerage system or impair biological dosage treatment plants. So that for maintaining pH we have to add acidic / basic medium neutraliser.
